  - And, provide evidence of availability of financial resources to successfully complete the works in the amount of **LKR 4.7 Mn for Package 01 & LKR 10.3 Mn for Package 02** Otherwise, you will not be considered further (Please refer the RFQ documents).
- The successful bidder shall not have associated with the firm that prepared the design, and specifications of the contract that is subject of this procurement.
